Letter from Cobalt President Karen Middleton: A Challenging and Productive Year

Dear Friends,

I don't need to tell you what a challenging year 2021 was, physically and emotionally, for all of us. Yet despite the challenges, Cobalt has much to be proud of as we build on our mission of protecting and expanding abortion rights for all. We are meeting the moment with action and building for the future.

The Cobalt Abortion Fund saw incredible growth in the number of clients it served, as abortion restrictions in other states saw more and more people seeking care here in Colorado. We networked with abortion funds and support networks in other states to connect patients and providers. We have never turned away a client and never will.

Our non-profit 501c3 and political 501c4 arms also saw explosive growth. And in an exciting new development, we announced TWO endowments, one for the Cobalt Abortion Fund and one for the Cobalt Foundation to expand our work advancing abortion access statewide.

And as Cobalt President, I was able to step away this fall for a sabbatical to renew and re-energize. I will use that new energy to focus on Cobalt's future. **Cobalt is strongly positioned with the institutional knowledge and political strategy needed to dig in and lead.** I hope you will join me.

Values: We are courageous, unified, principled and rooted


Courageous: We establish a bold direction, set audacious goals and then do what it takes to achieve them. This includes employing innovative tactics, confronting obstacles directly, and having difficult conversations when needed.

Principled: We are ruthless about the accuracy and reliability of the information we curate, investigate, and share. We treat our partners, members and allies with the same respect, providing credible, fact-based information in a timely and trustworthy manner.

Unified: Nobody can achieve unassailable autonomy until we all do. If one person's freedom over their own body is threatened, that impacts us all. We actively seek programs, strategies and collaborations that are led by, beneficial to and reflective of all genders, races, and backgrounds.

Rooted: We understand that each individual's health autonomy is at the core of our vision. To guide that focus, we work deeply with impacted communities. We are in constant relationship with the providers, advocates and impacted individuals to understand their unique needs and amplify their stories.

In 2021, Cobalt raised \$1.55M, exceeding our goal of \$1.42M for the year.



The Cobalt Foundation is the engine of the organization that powers all of the programming that we do: advocacy, outreach and education statewide, civic engagement, voter turnout, practical support and cash assistance for abortion access, collaboration with our regional and local coalition partners, and taking care of our Cobalt family.

Since 2012, Cobalt's annual budget has grown by 278%



Our first post-abortion long-acting reversible contraception (LARC) grant opportunity was a success.



The Cobalt Abortion Fund has never turned away a client.



"We served 22 clients with \$25,000 in LARC funding from the first Caring for Colorado grant. Devices ranged from \$500–1000 in cost. We piloted with two independent providers who identified patient need based on factors such as: little or no insurance, low income, teen/youth, or undocumented status."

The Impact of SB8 in Texas

- Since State Bill 8 went into effect in Texas on September 1, 2021, 75% of Cobalt's practical support funding has gone to support people traveling from Texas to Colorado for abortion care.
- In that same time frame, 33% of Cobalt Abortion Fund recipients were from Texas.
- Cobalt works closely with providers, abortion funds, and practical support organizations through the Regional Abortion Alliance to help streamline care for clients who have to travel for abortion care.



Although COVID-19 curtailed much of our in person outreach we did manage to participate in the Juneteenth Festival and the Colorado Black Arts Festival.


















Cobalt partnered with Fortaleza








Gala
